
# **Construction activities for the week of September 17**

## I-805 to Heritage Road (Segment 1A) - City of Chula Vista

- Intermittent sidewalk closures at the intersection of East Palomar Street and Oleander Avenue.
- Intermittent lane closures on East Palomar Street between Oriole Place and Gould Avenue.
- Closure of far right lane on westbound East Palomar Street from Medical Center Drive to Heritage Road.
  - The MTS bus stop east of Medical Center Drive on East Palomar Street has been relocated just west of Medical Center Drive.
- 24 hour no parking on westbound East Palomar Street between Medical Center Court and Davies Drive.
- Sidewalk closed along the east side of Medical Center Court from Tivoli Villas to the intersection of Medical Center Court and East Palomar Street and along the north side of East Palomar Street between Medical Center Court and the Missions at Sunbow Apartments.
- Sidewalk closed along the east side of Santa Olivia Road from Strawberry Creek Street to the intersection of Santa Olivia Road and East Palomar Street. All north-south pedestrian traffic crossing East Palomar Street will occur on the west side of the intersection.
  - o The westbound East Palomar Street MTS bus stop near Santa Olivia Drive is relocated further west.
- Far right lane of eastbound East Palomar Street closed from Santa Carina Road to just past Heritage Road. Right turns from East Palomar Street to southbound Heritage Road will still be allowed.
  - o One left turn lane closed from southbound Heritage Road to eastbound East Palomar Street.
- The westbound East Palomar Street MTS bus stop near Santa Maria Drive is relocated further west.
- Southbound right turn lane closed at the intersection of East Palomar Street and Heritage Road to accommodate curb ramp improvements. Right turns will still be allowed onto westbound East Palomar Street from the right southbound lane. Pedestrian detours will be in place.

#### Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista

Periodic noise, dust, and continuous closure of the left (No. 1) lane on eastbound East Palomar Street between Olympic Parkway and Magdalena Avenue for guideway construction.

## Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista (cont.)

- Daytime closure of existing westbound East Palomar Street, between View Park Way and Magdalena Avenue, Monday through Friday, from 8 a.m. and 5 p.m., to accommodate the installation of electrical lines. Westbound traffic detour will be in place via the new bus guideway. Work will take approximately five to six weeks to complete.
  - Parking will be restricted along westbound East Palomar Street, between View Park Way and Magdalena Avenue, Monday through Friday, from 8 a.m. to 5 p.m.
- Periodic daytime noise, dust, and traffic control along East Palomar Street and Magdalena Avenue to accommodate Santa Venetia Station construction and installation of new traffic signals.
- Periodic noise, dust, and vibration due to bridge finishing work, landscaping and minor retaining wall improvements adjacent to the transit guideway bridge.
- Ongoing sidewalk closure adjacent to Treviana community between Magdalena Avenue and SR 125 to accommodate guideway bridge staining.
  - All east-west pedestrian traffic will be detoured south of the closure area for the next two to three weeks.

#### Town Center Drive to Birch Road (Segment 2) – City of Chula Vista

- Periodic daytime noise and dust along Eastlake Parkway adjacent to Kestrel Falls Road while crews continue to work on the future Otay Ranch Station.
- Periodic daytime noise and dust at Town Center Drive and Mall Ring Road while crews perform site improvements.
- Intermittent lane closures on Mall Ring Road while crews work on sidewalk and pavement improvements.

#### Nicola Tesla Court (Segment 3) – City of San Diego

- Periodic noise and dust along the eastbound State Route 905 (SR 905) on-ramp from Siempre Viva Road to accommodate ramp improvements.
- Periodic noise, dust, and reduced on-street parking at Nicola Tesla Court near the Otay Mesa Port of Entry to accommodate the ingress and egress of construction equipment.
  - No on-street parking on south side of Nicola Tesla Court.
- Temporary pedestrian detour beginning September 6 through September 21 along Nicola Tesla Court to accommodate ongoing curb, electrical, and utility work.



















## Nicola Tesla Court (Segment 3) – City of San Diego (cont.)

- Closure of the far left lane on westbound Siempre Viva Road, from Paseo de las Americas to Otay Center, on Wednesday night, September 19, from 7 p.m. to 5 a.m. to allow crews to work on utility improvements.
  - o The eastbound SR 905 on-ramp on Siempre Viva Road will be closed overnight on Wednesday, September 19, from 7 p.m. to 5 a.m. to accommodate this work.
- Closure of the two left lanes on eastbound Siempre Viva Road, from Customhouse Plaza to eastbound SR 905 off-ramp at Siempre Viva Road, on Thursday night, September 20, from 7 p.m. to 6 a.m. to allow crews to work on utility improvements.
  - o The eastbound SR 905 off-ramp to eastbound Siempre Viva Road will be closed overnight on Thursday, September 20, from 7 p.m. to 5 a.m. to accommodate this work.
