ABOUT THE PROJECT

The Uptown Bikeways will enhance neighborhood connectivity between Uptown, Old Town, Mission Valley, Downtown, North Park, and Balboa Park; promote active living and healthy communities; and make streets safer for people who bike, walk, drive, and take transit. The project has been refined based on extensive community outreach, a process that will continue through the final design and construction phases. Construction is expected to begin in 2017 on the first segment, which includes Fourth and Fifth avenues from B Street to Washington Street, connecting Downtown, Bankers Hill, and Hillcrest.

ABOUT TONIGHT'S OPEN HOUSE AND PUBLIC HEARING

The open house and public hearing marks a key milestone for the project. After several years of community outreach and project refinement, the SANDAG Board of Directors is anticipated to consider whether the project is exempt from the California Environmental Quality Act (CEQA) at its June 24, 2016 meeting. As part of the project's CEQA compliance, SANDAG prepared a Traffic and Safety Impact Assessment, which was published May 9, 2016. Open house and public hearing attendees will be able to talk with project team members and provide feedback.
