



- Provides opportunity for two-way bikeway





# CONSIDERATIONS


- Does not provide direct commercial corridor access



# CONSIDERATIONS

- Located directly on commercial corridor
- Separates users: bikes, pedestrians, vehicles (University)
- Supports placemaking and pedestrian-friendly design
- Improves safety through traffic calming design and separating users
- Increases visibility and accessibility of local businesses
- Supports a more contiguous east-west corridor
- Removal of parking spaces on University Ave (estimated 11 spaces)
- Requires median reconstruction/refinement on University and Normal

Looking Eastbound on Robinson Avenue






