ABOUT THE PROJECT

The Central Avenue Bikeway will provide a safe connection to many destinations within the San Diego communities of City Heights, Kensington, and to adjacent neighborhoods. Starting at the north end, the 1.2 mile bikeway will begin in Kensington where the SR 15 Commuter Bikeway ends at Adams Avenue and continue south, parallel to SR 15, along Terrace Drive and Central Avenue to Landis Street in City Heights.

ABOUT TONIGHT'S OPEN HOUSE AND PUBLIC HEARING

The open house and public hearing marks a key milestone for the project. After several years of community outreach and project refinement, the SANDAG Transportation Committee is anticipated to consider whether the project is exempt from the California Environmental Quality Act (CEQA) — under Public Resources Code Section 21080.20.5 — at its April 20, 2018 meeting. As part of the project's CEQA compliance, SANDAG prepared a Traffic and Safety Impact Assessment, which was published February 9, 2018. Open house and public hearing attendees will be able to talk with project team members and provide feedback.

PUBLIC COMMENT AND HEARING OVERVIEW

The public hearing will be held near the stage, where you will have the opportunity to provide verbal public comments on the project. Written comment forms are available as well. The written and verbal comments collected at tonight's open house and public hearing, as well as responses to those comments, will be provided to the SANDAG Transportation Committee for consideration prior to the committee taking any action related to the project's CEQA exemption.

For verbal comments:

- Speaker slips will be accepted starting at 6 p.m.
- Speakers will be called in the order in which speaker slips are submitted
- Verbal comments may also be given directly to the court reporter, beginning at 6 p.m., and will be included in the public record of the hearing
