

SANTA FE STREET PARKING CHANGES

Within the next two weeks, crews will begin the removal of parking on the east side of Santa Fe Street, between Karl Strauss Brewing Company and Coventry Cars of San Diego, in preparation for construction of the Rose Creek Bikeway.

What to Expect

- Within the next two weeks, street parking will be permanently removed on the east side of Santa Fe Street, between 5959 and 5097 Santa Fe Street. Signs will be placed along Santa Fe Street once the removal has been scheduled, to provide advanced notice.
- A portion of the parking removal on the east side of Santa Fe Street, between 5965 and 5985 Santa Fe Street, is temporary and will be restored after the bikeway is complete in 2020.
- Portions of Santa Fe Street will be intermittently reduced to a single lane during construction. Please follow all posted signage carefully during these times.
- Construction will generally take place during the day, from 7 a.m. to 5 p.m., but night and weekend work may also be required.
- Work activities will include utility work, drainage improvements, street widening, and bikeway construction.
- Crews will minimize impacts as much as possible.
- Access to properties will be maintained.

Construction schedules are subject to change due to weather, equipment, and other issues. Check KeepSanDiegoMoving.com/MidCoastNotices for regular schedule updates.

About the Project

The Rose Creek Bikeway is part of the Coastal Rail Trail and is a Class I bike path (completely separated from vehicle traffic). It connects existing sections of the Rose Canyon and Rose Creek bike paths in the City of San Diego.

The bikeway will begin at the north end of Santa Fe Street and connect to the existing Rose Creek Bike Path at the intersection of Damon Street and Mission Bay Drive.
