HOWARD – ORANGE BIKEWAY

The Howard – Orange Bikeway will be more than 3 miles and is one of six segments planned as part of the San Diego Association of Governments (SANDAG) 13-mile North Park | Mid-City Bikeways. These bikeways will make it safer and easier for people of all ages and abilities to bike to more places within and between the North Park and Mid-City communities.

PROVIDE YOUR FEEDBACK

The July 27 open house and public hearing marks an important step for the Howard -Orange Bikeway project, SANDAG, as the lead agency under the California Environmental Quality Act (CEQA), will hold a public hearing to hear comments on the proposed project. During the open house portion of the meeting, attendees will have the opportunity to talk with project team members and provide feedback. Spanish translation and interpretation will be provided. The SANDAG Transportation Committee is anticipated to consider whether the proposed project is exempt from CEQA at its September 15, 2017 meeting. Comments collected at the public hearing and open house and written responses to those comments will be provided to the Transportation Committee for its consideration before their September 15. 2017 meeting.


