



The proposed Border to Bayshore Bikeway is an approximately 6.5-mile bikeway that would establish a key biking connection between the communities of Imperial Beach and San Ysidro. The project strives to make it safer and easier for people of all ages and comfort levels to bike to commercial centers, schools, transit stations, and other community destinations.

## ABOUT TONIGHT'S OPEN HOUSE AND PUBLIC HEARING

The open house and public hearing marks an important step for the Border to Bayshore Bikeway project. SANDAG, as the lead agency under the California Environmental Quality Act (CEQA), will hold a public hearing to hear comments on the proposed project. During the open house portion of the meeting, attendees will have the opportunity to talk with project team members and provide feedback. The SANDAG Transportation Committee is anticipated to consider whether the proposed project is exempt from CEQA at its December 14, 2018, meeting. Comments collected at the public hearing and open house and written responses to those comments will be provided to the Transportation Committee for its consideration before the December 14, 2018, meeting.
