



## ABOUT THE PROJECT

The Imperial Avenue Bikeway will help create safer streets for people who walk, bike, drive, and take transit in the Southeastern San Diego Community. The 3-mile bikeway will provide improvements along Imperial Avenue between 17th Street and 47th Street. Potential project features include high visibility crosswalks, curb extensions, raised crosswalks, separated and buffered bike lanes, and shared lane markings. These walking and biking enhancements will improve safety for all roadway users. A future phase will provide improved connections to the community from Downtown San Diego.

## ABOUT TONIGHT'S OPEN HOUSE AND PUBLIC HEARING

The open house and public hearing marks an important step for the Imperial Avenue Bikeway project. SANDAG, as the lead agency under the California Environmental Quality Act (CEQA), will hold a public hearing to hear comments on the proposed project. During the open house portion of the meeting, attendees will have the opportunity to talk with project team members and provide feedback. The SANDAG Transportation Committee is anticipated to consider whether the proposed project is exempt from CEQA at its May 18, 2018 meeting. Comments collected at the public hearing and open house and written responses to those comments will be provided to the Transportation Committee for its consideration before their May 18, 2018 meeting.
