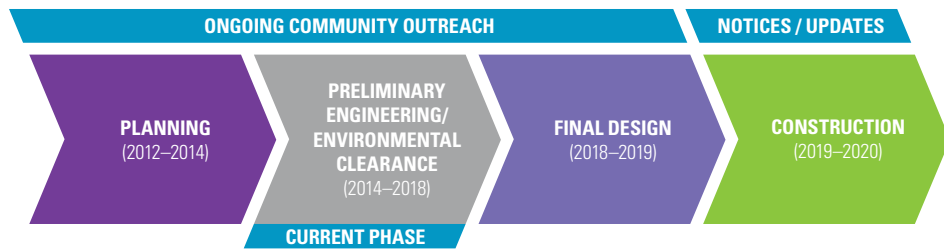

ABOUT THE PROJECT

The proposed University Bikeway will provide a vital connection for residents to walk and bike between vibrant communities within San Diego's urban core – City Heights, Eastern San Diego – and La Mesa. Proposed features include separated bike lanes, buffered bike lanes, high visibility treatments, and protected intersections designed to make the streets more pleasant for everyone – people who walk, bike, work, and live there. The University Bikeway will run along University Avenue, between Estrella Avenue and 70th Street. The proposed bikeway will also provide an important connection to the Howard – Orange Bikeway to the west and an entire network of high priority regional bikeways just beyond.

ABOUT TONIGHT'S OPEN HOUSE AND PUBLIC HEARING

The open house and public hearing marks an important step for the University Bikeway project. SANDAG, as the lead agency under the California Environmental Quality Act (CEQA), will hold a public hearing to hear comments on the proposed project. During the open house portion of the meeting, attendees will have the opportunity to talk with project team members and provide feedback. The SANDAG Transportation Committee is anticipated to consider whether the proposed project is exempt from CEQA at its June 15, 2018 meeting. Comments collected at the public hearing and open house and written responses to those comments will be provided to the Transportation Committee for its consideration before their June 15, 2018 meeting.

PUBLIC COMMENT AND HEARING OVERVIEW

During the public hearing portion of the meeting, you will have the opportunity to provide verbal public comments on the project. Written comment forms are available as well. The written and verbal comments collected at tonight's open house and public hearing, as well as responses to those comments, will be provided to the SANDAG Transportation Committee for consideration prior to the committee taking any action related to the project's CEQA exemption.

For verbal comments:

- Speaker slips will be accepted starting at 6 p.m.
- Speakers will be called in the order in which speaker slips are submitted
- Verbal comments may also be given directly to the court reporter, beginning at 6 p.m., and will be included in the public record of the hearing
