## South Bay Rapid is Under Construction

The list below shows planned construction activities for the South Bay *Rapid* project. Travelers are encouraged to allow extra time to reach their destination or consider using alternate routes. Please note, construction schedules are subject to change and community members may see trucks and staged equipment at various locations around the project.

**CONSTRUCTION ADVISORY:** Construction of the dedicated transit guideway on East Palomar Street between Heritage Road and Paseo Ladera has begun. Motorists can expect reduced lane widths, lane closures, restricted turn lanes, and traffic control in the area. Motorists are encouraged to give themselves more time and anticipate traffic delays or consider taking an alternate route to reach their destination. This work is expected to continue through spring 2019.

### Construction activities for the week of January 21

#### Corridor-Wide Safety Information

Nearby residents and motorists can expect to see not in service MTS buses traveling the route beginning January 15 for training purposes. Training activities will take place until the full service launch of the South Bay *Rapid* on Sunday, January 27. Please be aware that pedestrians should stay on designated sidewalks and refrain from entering the guideway. Motorists should obey all traffic signs and never enter the guideway.

#### **I-805 to Heritage Road (Segment 1A) – City of Chula Vista**

- Intermittent sidewalk closures at the intersection of East Palomar Street and Oleander Avenue.
- Intermittent lane closures on East Palomar Street between Gould Avenue and Oriole Place.
- Closure of left lane on westbound East Palomar Street from Heritage Road to Paseo Ladera.
- Closure of right lane on westbound East Palomar Street from Paseo Ladera to Medical Center Drive.
- 24 hour no parking on westbound East Palomar Street between Medical Center Court and Davies Drive.

## South Bay Rapid is Under Construction

- Sidewalk detours in place for pedestrians traveling west along the north side of East Palomar Street between Medical Center Court and Davies Drive.
- Temporary concrete barrier (k-rail) in place along the far left lane of eastbound East Palomar Street between Paseo Ladera and Brashear Place.
- Closure of the left lane on eastbound East Palomar Street between Paseo Ladera and Heritage Road.
  - One left turn lane closed from southbound Heritage Road to eastbound East Palomar Street.
  - The far right lane, including the bicycle lane, on eastbound East Palomar Street will be available for use by motorists and bicyclists.
- No left turns will be allowed at the intersection of Brashear Place beginning Tuesday, January 22 through Friday, January 25 between 9 a.m. and 2 p.m., to accommodate trenching operations.
  - The traffic signal at Brashear Place will be set on red flash during these times.
- No left turns will be allowed on East Palomar Street at the intersections of Santa Maria and Santa Sierra drives. Pedestrian access to crosswalk is available.

### Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista

- Periodic daytime noise as crews install guardrail systems in the median of SR 125 and conduit on the northbound shoulder for future MTS fiber optic communications.
- Daytime closure of East Palomar Street between View Park Way and Magdalena Avenue on Monday, January 21 from 8 a.m. to 5 p.m. to accommodate parking lot resurfacing improvements.
  - Traffic will be detoured via the new bus guideway during this time.
- Restricted parking on East Palomar Street between View Park Way and Magdalena Avenue beginning Monday, January 21 at 8 a.m., through Tuesday, January 22 at 5 p.m., to allow for a required 33 hour cure time of the newly resurfaced parking lot.

### Town Center Drive to Birch Road (Segment 2) – City of Chula Vista

- Periodic daytime noise and dust along Eastlake Parkway adjacent to Kestrel Falls Road while crews continue work on Otay Ranch Station.
- Periodic daytime noise and dust at Town Center Drive and Mall Ring Road while crews perform site improvements.
