



The list below shows planned construction activities for the South Bay *Rapid* project. Travelers are encouraged to allow extra time to reach their destination or consider using alternate routes. Please note, construction schedules are subject to change and community members may see trucks and staged equipment at various locations around the project.

### Construction activities for the week of February 12

#### **Interstate 805 to Heritage Road (Segment 1A) – City of Chula Vista**

- Lane closures along westbound East Palomar Street between Davies Drive and Medical Center Drive. These closures are in place 24/7 for retaining wall and utility relocation work. Pedestrian detours will be in place. The bus stop east of Medical Center Drive has been relocated to the west side of Medical Center Drive.
- Lane and sidewalk closures along westbound East Palomar Street between Heritage Road and Paseo Ladera. These closures are in place 24/7 during sidewalk demolition and construction.
- Periodic daytime lane closures on East Palomar Street and Oleander Avenue near the intersection. These closures will allow crews to conduct preparatory work for the installation of underground communication utilities.
- Temporary bus stop closure along East Palomar Street at Brashear Place. For MTS schedules, detours, and routes during this closure, please visit [www.SDMTS.com](http://www.SDMTS.com).

#### **Heritage Road to View Park Way (Segment 1B) – City of Chula Vista**

- Periodic lane closures in both directions along East Palomar Street between Heritage Road and Olympic Parkway for continued road work improvements.

#### **Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista**

- Periodic daytime closures of one westbound lane on Olympic Parkway between SB SR-125 Off-Ramp and La Media Road between 9:00 a.m. and 5:00 p.m. Temporary signage will be in place to alert motorists. Motorists can expect short delays.



### **Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista (continued)**

- Periodic daytime closures of the left turn pocket on northbound East Palomar Street onto Olympic Parkway between 8:30 a.m. and 3:30 p.m. Temporary signage will be in place to alert motorists. Motorists can expect short delays.
- Periodic noise, dust and daytime lane closures along East Palomar Street between Santa Cora Avenue and Magdalena Avenue for construction of the guideway.
- Periodic noise and dust along Impressionist Drive for construction of the guideway bridge barrier and privacy walls.

### **Town Center Drive to Birch Road (Segment 2) – City of Chula Vista**

- Periodic noise and dust along Eastlake Parkway adjacent to Kestrel Falls Road while landscape crews continue underground utility work.

### **Millenia – City of Chula Vista**

- Periodic noise and dust near the Millenia development for construction of the dedicated transit guideway and Millenia *Rapid* Station.

### **Nicola Tesla Court (Segment 3) – City of San Diego**

- **Thursday night, February 15:** Full closure of the eastbound SR 905 off-ramp to westbound Siempre Viva Road between 7 p.m. and 5 a.m. Motorists wishing to travel along Siempre Viva Road west of SR 905 will be detoured to southbound La Media.
- **Thursday night, February 15:** Full closure of the eastbound SR 905 on-ramp from Siempre Viva Road between 7 p.m. and 5 p.m. Motorists wishing to travel eastbound on SR 905 will be detoured to the La Media Road on-ramp.
- **Friday, February 16:** Full closure of the eastbound SR 905 off-ramp to westbound Siempre Viva Road between 9 a.m. and 3 p.m. Motorists wishing to travel along Siempre Viva Road west of SR 905 will be detoured to southbound La Media.
- Periodic noise and dust along the eastbound State Route 905 (SR 905) on-ramp and off-ramp from Siempre Viva Road from construction activities on the ramps.

- Periodic noise, dust, and reduced on-street parking at Nicola Tesla Court near the Otay Mesa Port of Entry to accommodate grading and construction of underground facilities and a retaining wall.
  - No on-street parking on south side of Nicola Tesla Court.
